## **Project Aim and Objectives**



NATIONAL CENTRE FOR THE PROTECTION OF OLDER PEOPLE (NCPOP)

#### **Overall Aim**

To **promote resilience** in family carers of people with dementia using participatory action research to develop an innovative Enhancing Carers' Resilience (EnCaRe) programme.

#### **Objectives**

- Synthesise current evidence of resilience-enhancing and related psychosocial interventions and initiatives aimed at promoting positive outcomes for family carers
- 2. Measure and **describe family carers' experiences** of caring for a person with dementia and their resilience in caregiving
- 3. Establish a network group comprising family carers of people with dementia and members of the research team and, through the network, develop and design an Enhancing Carers' Resilience (EnCaRe) Programme
- **4. Conduct a feasibility study** of the EnCaRe Programme through a demonstration project among a cohort of current family carers of people with dementia
- **5. Evaluate the EnCaRe Programme** with reference to structure, process and outcome elements



## Research Design

A participatory action research framework based on the principle of collaborative inquiry with the aim of enabling and facilitating carers to develop an Enhancing Carers' Resilience (EnCaRe) Programme for family caregivers of people with dementia.










## Systematic Review



Complex psychological construct comprising of many different aspects of carers' lives.


Cutlines different resources, assets and factors shown to affect carer outcomes.

Similarities with the model outlined by Cherry et al. (2013) but additional factors were identified.



## **Meta-analysis**

- Support interventions had a positive significant impact on caregivers' levels of burden, depression and general health.
- Although non-significant, there was a positive trend toward increased quality of life in family carers post intervention.

• 485 respondents indicated that they cared for a person with dementia (aged 65 years and older).

## Methodology

- An anonymous cross-sectional postal survey of family carers of people with dementia
- Family carers in receipt of a carer's allowance for the care of a person with dementia
- The Department of Social Protection (DSP) facilitated 3 mail-outs.
  - Mail-out 1: Pre-notice letter
  - Mail-out 2: Cover letter, questionnaire & SAE
  - Mail-out 3: Reminder/thank you letter, spare questionnaire & SAE






## Methodology

## The EnCaRe Network group

- Up to six family carers of people with dementia
- Two research team members
- Meetings every 4-6 weeks
- Using a mix of invited speakers and group discussions to address group aims

## **EnCaRe Network Group Aims**

- Develop a grounded definition of 'resilience' based on carers' experiences
- A programme designed by carers for carers to enhance resilience of Family Carers of people with dementia (PWD)



## Recruitment

#### Recruitment

Following ethical approval a recruitment strategy was formulated and rolled out

## **Recruitment Strategy**


- Worked with collaborators to recruit family carers of people with dementia
- Strategy targeted:
  - mix of caregiving relationships (18+)
  - male & female carers (18+)
  - current & former carers (18+)
- Used social media and pamphlet to target these groups through existing carer networks

## Currently the EnCaRe Network Group comprises:

- 8 members (+2 research staff)
- 4 men and 4 women
- 6 adult-child carers; 2 spousal carers
- Mix of caring experiences





## **EnCaRe Network Group Sessions**







- To date there have been a total of 5 Sessions
- 2-3 hours long
- Have heard from guest speakers on topics of interest to the group
- Earlier sessions focused on concept of resilience as well as policy as it relates to Family Carers of PWD



#### Information

- Lack of information has been highlighted as a key challenge for family carers
- Fragmented; FCI, CAI, ASI, HSE, Genio, Understand Together, GPs, PHNs etc.

#### Information

- Family Carers can't find information they need
- Why is this?
- Undermines resilience of Family Carers of people with dementia

- Role of co-researcher


